Presidents Musings for June 2019

It's June and the birds are singing, the grass is growing and the fish are biting along with the mosquitoes. It was a long, cold and snowy winter, but now we have the beginning of another season on this beautiful chain of lakes. It is in all our best interests to keep the lakes clean, clear and free of invasive species, so let's all do our part.

The next water chemical sampling/analysis will be conducted in 2020 and 2021. Our Water Quality Management Plan has us doing this for two years between the MPCA sampling. The cost of the procedure can be significantly reduced if we can get enough volunteers to physically perform the water collections once each month from May to October. If we can do our own collection (after training) we might be able to check more locations. If you are interested in helping please contact Mark Conover (507 317-0344).

There is a lot going on in regard to aquatic invasive species (AIS). The Itasca County AIS coordinator conducted a Lake Service Provider conference which WCOLA supported. There is a new program called Five Star for certified lake service providers to encourage serious attention to the possible movement of AIS from infected waters to noninfected. We have two new AIS Detectors on the chain, WCOLA and Wabana Township have again donated funds towards AIS inspections at the boat landings, and the Itasca County AIS web site has been updated.

The Wabana Township Board of Supervisors has continued to work on solutions and a way forward for Ordinance 101. They have conducted a number of public hearings and established a Planning Commission to manage the implementation and create any revisions needed.

The first of the annual road clean-ups has been completed already with the second scheduled for September 25. The annual June Social gathering is scheduled for June 8 at the Bluewater CampFire Camp, the Bill Downing Memorial summer solstice party will be June 21, and the annual picnic will be July 20. The WCOLA annual meeting will be August 17, with the Itasca County Historical Society doing a presentation about Summer Camps on our chain of lakes . Itasca Waters again hosted the Water Youth Summit for $^{\sim}500~5^{th}$ grade students and is planning a "We Are Water" presentation in Grand Rapids in August.

Elections for the WCOLA President and Vice President positions will be conducted this summer and the nominating committee welcomes anyone wanting to apply. Please contact Susan Lick (218 326-6837). Ballots will be distributed in late July and the results presented at the annual meeting on August 17.

Boating Etiquette

Last season we again received a number of complaints regarding loon and other wild life harassment, but more specifically boat wake issues around docks and other boats. Last year we with the County Sherriff's office placed "slow no wake signs at each end of the three interlake channels as a means of protecting the environment and loon nesting areas.

The laws prohibit any wild life harassment and it is just plain cruel and wrong.

The use of "wake boats" on the chain of lakes last summer caused additional issues. Wake boats create large waves so the rider can literally surf behind the boat. This is fine in the large open areas of the lake where the wake probably won't bother other boats at docks or fishing; however in constricted waters the wake can cause considerable damage. "It is against the law: To operate a watercraft so its wash or wake endangers, harasses, or interferes with any person or property". So for example, should a wake cause damage to a boat at a dock, the offender would be responsible. Should you witness any really offensive behavior, try to take a photo and get the boat license then call the sheriff's office. The other concern with wake boats is that they must take on ballast (water) in order to create the wake. Then when preparing to load the boat back on a trailer, they must pump out the water. Unfortunately you can not completely empty the tanks thus providing a wonderful environment for AIS to potentially grow and get dumped into a noninfested lake

Another serious concern is damage to plant life when boats speed through shallow areas especially the channels between the lakes. The paragraphs below are an excerpt from a publication of RMB Labs.

We tend to think of aquatic plants as bad for recreation, but they are very important to organisms living in the lake. When a boat or jet ski speeds through reeds or aquatic plants, it can cause disturbance to these sensitive areas. First, it stirs up the lake sediment, re-suspending nutrients (phosphorus) that are at the lake's bottom. When these nutrients reach the surface of the water where the algae are, they can feed algae and cause and algal bloom. This stirring can also decrease the water clarity because of additional particles suspended in the water column.

Secondly, props can cause direct damage to aquatic plants, cutting them up and decreasing their use as a shelter for fish. Please avoid driving through reeds and bulrushes with jet skis and boats. Thirdly, props and wave action can disturb sensitive habitat for spawning fish and other organisms.

"Slow no wake" means operation of a watercraft at the slowest possible speed necessary to maintain steerage, but in no case greater than 5 miles per hour.

Please encourage your visiting friends, relatives, and guests to be good boat stewards and respect others, the waters, and the wildlife.

AIS (Aquatic Invasive Species) Update

Concerns for Aquatic Invasive Species spreading continue with Zebra Mussels moving quickly down the Mississippi from Lake Winnibigoshish. There are 22 Zebra Mussel infected lakes in Itasca County, 12 with Faucet Snails, 5 with Eurasian Milfoil, 11 with Curly Pondweed, 56 including Trout Lake with Purple Loosestrife, 5 with Flowering Rush and 1 With Starry Stonewort (Winni). One of many actions to impede the spread was the Lake Service Providers Summit held this spring by the Itasca AIS Program and DNR and supported by a number of associations including WCOLA. The purpose was to educate lake service providers in methods, procedures and rules associated with dock and/or lift installation, or boat/trailer movement and what should be done to reduce chances of AIS movement from one lake to another. Lake Service Providers, that is anyone providing a service involving the lakes for money, are required by law to be DNR Certified. A provider who hasn't yet been certified can contact the DNR and Itasca AIS coordinator will refund the certification cost. A new program called Five Star (brochure mailing sent in March) has been implemented to further AIS awareness and apply AIS safeguards. This program rewards providers who commit to a number of AIS avoidance measures. We have two resorts on the chain of lakes with boat launch facilities. Both Birch Bay Resort and Britton's Trout Lake Resort are DNR certified while Britton's is already Five Star approved and Birch Bay nearly so. They should be commended for their efforts to preserve these wonderful lakes. A great source of information on AIS issues can be found at ItascaAIS.info.

FIREWORKS

A local discussion among neighbors, about fireworks and water pollution became one of many reasons for changing a traditional cultural practice in the Wabana Lake area. One group of folks decided to move the shooting of fireworks away from off the dock, keeping the pollution further from local water sources. Besides the effects of fireworks on water, air and soil, wildlife such as loons, ducks, eagles, ospreys and their young, fish and other creatures were considered.

Recent studies have shown that many fireworks or pyrotechnics, contain chemicals such as fuels, oxidizers, binding agents, and others for coloration and sound effects. The contaminant in question is perchlorate, found in many fireworks. The contaminate is highly soluble in water and migrates quickly from soil to groundwater. Much of the concern is that perchlorate ingestion may pose interference with the production of thyroid hormones required for normal metabolism and mental function in humans. The risk to aquatic ecosystems contaminated with perchlorate has been found in fish in the head area and even more in the fillets. Percolate is also a major ingredient in rocket fuel, explosives, road flares as well as fireworks and from land with applied fertilizers.

Considerations should also include solid debris from fireworks floating to neighboring lakeshores and particulate drift in the air. Sound invasion negatively affects humans, as well as wildlife such as nesting loons, eagles and domestic animals. These measures can help to protect the waters and wildlife we cherish. -- Susan Lick
