LETTER FROM OUR PRESIDENT

WCOLA President's musings

May 2017

Here's hoping for another wonderful summer at the lake here in the North Land. I am so looking forward to lots of time on and in the crystal clear waters of the Wabana Chain of Lakes. I might even get some fishing in this year.

WCOLA again sent out a letter in January describing what we are and do as an organization and encouraging all of our lake people to join the association. The letter has apparently had some success as our membership increased last year considerably. We included a survey in this year's package, hoping to get a better understanding of what the lake property owners and association members want/expect from WCOLA. We did get a good response to the survey and I will describe the results later in this newsletter. One thing I will mention now is the overwhelmingly favorable response to our activities regarding the protection and monitoring of the waters. Thank you to all those who responded to the survey and all those who have joined/rejoined this year.

The MPCA has completed their water sampling for 2016 and published their findings on their web site <u>www.dnr.state.mn.us/lakefind/index.html</u>. It again shows that the chain of lakes is very healthy. The MPCA samples the water at 5 sites on three of the Wabana Chain of Lakes two years in a row, then doesn't resample for 10 years unless they find something really surprising. WCOLA will be sampling mid way through the MPCA schedule on at least 7 sites for two years in a row. We will adjust our plan should analysis of the MPCA data and RMB Lab reports indicate need for additional efforts. Unfortunately the RMB analysis and report has not yet been completed, although we are expecting it soon.

Additionally, RMB Labs, through a grant, has completed an AIS Risk Assessment and the report should be released soon. The assessment includes three lakes of the Chain. The WCOLA Board has decided to establish an emergency fund to deal quickly with AIS problems if found in the Chain of Lakes. The state and county function kind of slowly in these instances and are badly strapped for funding. So we have so far set aside \$2000 from contributions made by our members to be able to react quickly.

We have again provided \$1500 to AIS boat landing inspections, which have already begun for this season. The inspection function now is part of the Soil and Water Conservation District and continues to be led by Bill Grantges. They have recently released a YouTube video of AIS issues, which is excellent and can be viewed at <u>Itasca AIS Program You Tube Channel</u>. Itasca County has also updated their web site <u>www.ItascaAIS.Info</u>. Our water team will again get active in trying to develop a plan for additional actions WCOLA could/should take to minimize AIS problems in our lakes. There is also a new cabin owner on the chain of lakes who has signedup for the U of M sponsored AIS Detector/Tracker Program. This is a training program dedicated to helping detect early on potential AIS issues.

WCOLA has been fortunate to receive another memorial, which will be used to promote continued water quality. The Blackmore family has provided a donation and memorial in memory of Agnes Blackmore.

The summer calendar of events is shown later in this newsletter, but I wish to highlight a few here. Our spring road cleanup was completed Monday May 8. We had 14 helpers this time and covered a lot of territory. It always amazes me how much trash people throw out of their car windows. The Bluewater Bible Camp has also offered to help and will cover Bluewater Road after Memorial Day. Secondly, our Spring Social Event (Kickoff Saturday June 10) gathering will again be held at the Bluewater Camp Fire Camp. This turned-out to be a great venue and as always is a great opportunity to meet and greet your neighbors. This year we have a real treat with John Latimer attending. John will give a talk on plants and animals of interest from around the lakes. He is always fascinating to listen to and he has spectacular photos. Thirdly, John Downing will again

host the Bill Downing Memorial Summer Solstice Party on Wednesday, June 21, at the Downing cabin and dock. This is again a great opportunity to talk to your friends on the lakes.

Finally, elections for WCOLA President and Vice President are coming up at our annual meeting scheduled for August 12. A nominating committee will be formed to look for new candidates. Additionally we are currently short 2 Board of Director members. So please, If you have any interest in leading or just participating as an officer or board member let us know. This is your opportunity to get involved and bring some new ideas to the association.

WCOLA Survey Results

The survey WCOLA sent out to all Wabana chain of lakes property owners in January was intended to provide the recipients with an opportunity to tell us what is important for the association to do. We received 48 responses, which overwhelmingly supported the actions taken and planned regarding the waters of our lakes. However twice as many indicated "no" for participation as indicated "yes". The survey results clearly indicate strong support for what WCOLA is doing, especially with regard to water quality, but much less interested in personal involvement. Thanks to all who returned their thoughts on the survey.

Water Quality

AlS inspections got the strongest ratings for importance with strong support for additional activities. Chemical sampling also received high marks for importance. Septic system and Mercury information, variance inspection and fish management information all ranked high but with ever decreasing importance.

Programs

Science based programs ranked highest followed closely by general information and much lower by entertainment.

Member Meetings

Annual only member meetings ranked slightly higher in importance than monthly, but way higher in support. This is kind of puzzling, especially when participation for both showed primarily a "NO". I wonder if this means won't attend or won't participate during the meeting?

Social Events

The responses indicate mediocre rankings for importance for both the kick-off social and picnic, but high numbers for support. Several surveys indicated that they were seasonal people and were not available much of the time. After this season your board intends to relook at continuation of these events.

Firewise, Road Clean-up, Historical

All showed more favorable for importance than not with generally high support counts.

Very few surveys indicated any response at all to these in terms of support and especially participation.

Comments

In creating this survey, my first, I made several mistakes one of which is not keeping names with the survey forms. As a result, most of the comments are from anonymous respondents. My intent had been to individually address each comment with the writer and in a few cases I have been able to do so. For all the other comments, I will try to address them here because I want our members to understand what we are doing and to know we are paying attention to their views.

Comment-Watch the DNR plans very closely as to their management ideas, which are not always in the best interest of protecting the lakes.

Response-We are interfacing with the DNR regularly especially on fish management plans, launch site cleanup and parties at the sites, etc. So far we have been working with IWLP and now Soil and Water on AIS issues. We will look into how to get the DNR more involved via our Water Quality Team. Comment-I would help or attend, but several comments indicated seasonal or even weekend time only at the lake, so it is difficult.

Response-We struggle as a board with timing on any WCOLA activities involving the membership. Saturdays are bad because they are so important in the summer for visitors and family and no one wants to go to a meeting or event away from the lake. Weekdays are bad because seasonal and weekend people are simply not here. So we reduced the association member meetings to one per year and scheduled other events later in the day. I can't think of another solution yet. **Comment**-I am not sure how to do the chemical or septic checks. But, I am willing to learn. **Response**-There isn't an awful lot for us lay people to do with these items. At this point WCOLA is just

do with these items. At this point WCOLA is just providing information on the septic systems usage. Several years ago, there was much more activity with county involvement and others including physical inspections etc. Experts hired for the purpose will most likely do chemical sampling. Our role will probably be providing a boat and driver once each month in the summers when they do the sampling. The companies we contract with will most likely collect the physical samples and do the actual chemical analysis and report preparation.

Comment-Do you have a directory of members with phone numbers, email and street addresses available for members?

Response-We published a list of members in the fall 2016 newsletter and again in this newsletter. We include the lake the member resides on but not the other info. We have discussed several times the privacy issues around this even though much of this information is in the local phone directory. There is a master database maintained, so any specific need can be answered.

Comment-There was apparently some confusion regarding the meaning of Support and Participate **Response**-I attempted to explain them in the survey directions. In any case, what I meant was: Support=do you agree that WCOLA should be doing the item: Participate=will you personally attend and or participate in the item.

Comment-Need to be careful to not overly focus on Lake Wabana at the expense of the other lakes in the chain.

Response-Several of the board members live on Wabana so it is sometimes hard to think more broadly, but we will try. We would really like to have more board members from the other lakes.

Comment-There was some write-in interest in other social activities, specifically the ice cream social and the two solstice parties.

Response-Individual WCOLA members actively participate and to some degree sponsor these activities as well as some others; however they are not WCOLA events per se. The ice cream social and hunters supper are both Wabana Community sponsored, while the solstice parties are hosted by the John Downing family (summer solstice) and the John Zimmerman family (winter solstice). WCOLA does share the cost of the ice cream social with the Wabana Community Fund. **Comment**-The DNR handles fish management already. **Response**-WCOLA is not attempting to manage the DNR fish program. The DNR invited us to attend a meeting where they described their initial plans for the next ten years. They also asked for our input. The WCOLA attendees sent a message to all lake property owners describing the key elements of the plan and asked for feedback. We continue to have discussions with DNR representatives on a variety of topics. Our intent is to influence the DNR on critical issues like musky stocking and making Wabana into a trophy fishing lake using the feedback i.e. giving you a voice.

Comment-WCOLA is **not** a government entity and therefore has no place conducting or participating in variance inspections or the like.

Response-You are right, WCOLA is not a government entity and has no authority regarding variance inspections. We are invited to attend county led inspections. However we can be a voice to be heard by those who do have the authority and we feel a responsibility to mention/discuss planned actions, which could harm our lakes.

Comment-With regard to science based programs "whose science"?

Response-Science based in this context was intended to be water oriented topic involving subject matter experts describing the subject with chemical or mathematical figures as opposed to, say fish catches or loon counts. **Comment**-Annual meeting is a good idea with possible additional meetings due to issues that could arise. **Response**-Our intent is to communicate all issues of significance to members and often all lake property owners. This is primarily done with email, however if really significant, we will augment with snail mail. Additionally, should any major issue require discussion or decision more than just opinion type feedback, meetings will be called.

Comment-In regard to AIS-More money should be put into biological research. Inspections are helpful, but AIS is probably inevitable.

Response-Unfortunately I am afraid you are right with respect to AIS being inevitable, what we can do with inspections is hopefully delay the process until research finds some solutions. More money invested into biological research would certainly help although probably beyond the scope of WCOLA. Although, we have established a fund specifically for emergency situations involving AIS eradication. In the several meetings and conferences I have attended, I am amazed at how much is already being done by state and other agencies like Sea Grant.

I would be happy to discuss these or other concerns with anyone, so please come to an event like the kickoff social or the summer solstice or the picnic or the annual meeting so we can. If you prefer, send me or anyone on the board a note or email.
